February 3, 2025 The Clarksville City Council met in regular session on February 3, 2025 in the City Council Chambers at 6:30 p.m. with Mayor Jerald Heuer presiding and Council Members Roger Doty, Ruth Saulsbury, Jennifer Kielman, Jessi Reints and Taran Sherburne. Other City employees present were: Molly Bohlen, City Clerk, Karmella Heuer, Deputy Clerk, Jared Brunner. Maintenance, and Reserve Officer Brown. Members of the public present: David Kramer and Brandon Kramer.

Motion Sherburne, Kielman to approve agenda as listed for February 3, 2025. Ayes: Saulsbury, Doty, Sherburne, Kielman, Reints. Nays: None. Absent: None. Motion Doty, Reints to open hear-

Heuer states that he has received complaints from residents regarding brush surrounding the house, and vermin including snakes and raccoons coming out of the house. David Kramer states that the brush and trees have been removed as of

today and the house is livable. He states that he is keeping the house because he may eventually move into it. Basement is old stone foundation and that seems to be where the animals are coming and going from. Brandon Kramer is helping with the work around the house and states that there was an egress window that has been removed in the basement and replaced with ply wood and he is planning to add dirt in that area. Reserve Officer Brown also states that she has received complaints about snakes and raccoons coming from the house. Heuer questions if he is planning on renting the property out. Kramer states that eventually he may move back in. Doty feels that if the brush is cleared that would help. Heuer questions if the foundation needs some work like spray foam. Saulsbury questions why the plastic is on the north side of the house. Brandon states that the bathroom in on the north side and that helps with when it gets cold so the pipes don't freeze. His plan is to take it down and replace with new and then in the spring to take the plastic down all together. Kielman wonders if plastic can be placed on the inside of the windows to help with the wind. Brandon stated that he

talked to Frankie Vance that afternoon and Frankie did not have a problem with the property and if it came up for sale he would like to buy it. Kramer also states that there is new flooring, new furnace, and new washer/dryer. Kramer states that everything is closed up where animals can't get in, but the back door needs replaced as there is evidence that some animals have been there, but they were not able to get in the house. Brandon states that he can get the door replaced within a month weather permitting. Sherburne feels that if the brush and yard are kept up with the property should be fine. Saulsbury has concerns with fire hazard due to the overgrowth. Brandon Kramer was able to show a picture of the outside of the house after removing brush today.

Any voter who requires assistance to vote by reason of blindness, disability, or inability to read or write may be given assistance at the polls by a person of the voter's choice, other than the voter's employer or agent of that employer, or officer or agent of the voter's union. Any voter who is physically unable to enter a polling place has the right to vote in

the voter's vehicle. Pre-registered voters must be registered to vote 15 days or more before the election to appear on the voter register on Election Day and will be required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered, such as voters registering to vote on election day and voters changing precincts, must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by noon on Monday, March 10th. Meeting called to order at 9:02 A.M. by Chairman Rusty Eddy with members Greg Barnett and Wayne Dralle present. Moved by Dralle second by Barnett to approve the agenda. All ayes. Motion carried.

Minutes of the previous meeting were read. Motioned by Barnett, second by Dralle to approve the minutes as read. All ayes. Motion

No public comment was received. Crisis Intervention Services presented on February National Teen Dating Violence Awareness. The proclamation was recited, and stats were given on teen dating violence.

Motion by Barnett, second by Dralle to make a Proclamation declaring February as National Teen Dating Violence Awareness month. All ayes. Motion carried.

An update was given on E911 Tower Land Acquisition Public Improvement Project. A date has been set for February 27th at 1:30 P.M. for the commissioners of the imminent domain board to meet and set a price for the land. Public notice will be posted and published.

FY26 Budget Workshops were

held for the following: · County Attorney - Dave Kuehner discussed on his budget and mentioned that the new software updates are now taken from the IT

· Planning & Zoning, Environmental Health - Misty Kofron detailed her budget. Some additions have been made to the Planning & Zoning budget to cover mileage for board members and professional fees have increased in the case that the pipeline comes into play and requires lawyer fees. Environmental Health does not have much changing outside of the potential for new equipment and mapping updates.

 Veteran Affairs – Tom Heckman stated that his budget is close to the same. There is an added item to cover mileage for commissioners.

• IT Director – Sara Trepp outlined her budget and relayed that

the computer programs item is up, equipment contracts have gone up slightly, and computer equipment has increased as updates are being made. Conservation is coming on the network which will include equipment and office licensing/security. Conservation will also have an iPad as they go on County Parks Online so that reservations can be made for camping through that site. Secondary Roads individuals now have emails which will be an additional cost throughout the year. Lastly, a switch will be made to T-Mobile as they have purchased U.S. Cellular.

• Sheriff - Jason Johnson detailed his budget and mentioned that the vehicles are a large expense as they need to be outfitted. Salaries have increased and there are a few positions that may require expenses toward training at the academy. He noted that comparatively, our deputies are making around \$10,000 less than surrounding counties. Additionally dispatchers are difficult to keep as other counties seek them out.

 Emergency Medical Services -Kari Coates stated that there are not many changes and that salaries are the largest items. She is looking for new vehicles which will be an increase once that is purchased. The levy fund will be around 14 cents and that will not begin until July, 2025.

Coates provided an update on the EMS Part-time employee and they have an individual that they would like to offer the position to. This position is scheduled to be approximately 20 hours per week to start. Motion by Dralle, second by Barnett to approve the position. All ayes Motion carried

Motion by Eddy to table the Engineers Update to the following week, second by Barnett. All ayes. Motion

Motioned by Barnett, second by Dralle to approve claims. All ayes Motion carried.
