No public comment was received. Board considered Resolution 1080-2023 regarding Windstream abatement. Roxie Nicolaus, County Treasurer, explained that the

abatement would resolve a double taxing. Moved by Eddy, second by Dralle to approve Resolution 1080-2023. Roll call was taken and resolution was passed as follows: RESOLUTION #1080-2023

BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF Butler County IA, that the Butler County Treasurer, pursuant to 2023 Iowa Code abate all taxes, interest and costs from the tax books for the following tax parcels.

Butler County Assessor. Accord-

ing to Senate File 2388 of the Eighty-seventh General Assembly, it changed how the property is valued and assessed for property taxation purposes. For assessed years 2020 and 2021, only the DOR should have assessed and taxed

the property.
THEREFORE, to avoid double taxation, it is necessary to remove the Butler County tax for those years.

Leslie Groen, Auditor, explained that they have a Resolution in place that allows them to transfer up to \$100,000 annually. Moved by Eddy, second by Dralle to Authorize Auditor transfer FY23 revenue

to the Butler County Conservation reserve accounts. All ayes. Motion carried. Board considered a utility permit for Butler County REC - underground service @ 15758 Packard Ave. Motioned by Eddy, second by Dralle to approve the utility permit for Butler County REC. All ayes. Motion carried.

Thomas Hoodjer, Assistant County Engineer, provided an update and mentioned that all updates on road construction and closures are provided on the County website. A radar box has been mounted north of Dumont in order to receive data regarding the speeding into town. After information is received, it will be used to determine whether any safety precautions need to be add-ed. The radar box may also be used in New Hartford and Clarksville, depending on time.
