Other City employees present were: Molly Bohlen, City Clerk, Karmella Heuer Deputy Clerk, Jared Brunner, Maintenance, Ryan McCully, Fire Chief, Chief Mackey and Reserve Officer Brown. Members of the public: Tereasa Hovenga & Matt Wilken.

Motion Sherburne, Doty to approve agenda as listed for August 4, 2025. Ayes: Sherburne, Saulsbury, Doty, Kielman, Reints. Nays: None. Absent: None

Ryan McCully wanted to let everyone know that the Fire Dept. is having a FUNDAY on 8/24/25 at Volunteer Park starting at 1 PM. There will be food trucks and activities for all.

Mayor Topics: Heuer wanted to give a shout out to the Maintenance Dept. for the great job they did with the last storm damage cleanup and to residents around town who pitched in to help others. Nuisance Properties: Heuer stated that the Police Dept. is the enforcement and to turn over to them buildings

that have missing windows, boarded up windows, weeds and grass that is over 6" tall, or if anyone sees rodents at places in town to report them. He told council to look around and let the Mayor or Police Pept.. know if they see anything. He referred to the State Code CH. 657 that explains dilapidated, properties abandoned for 6 months or more are nuisances and the City Ordinance-CH. 145.

Motion Kielman, Saulsbury to approve second reading of Ordinance No. 318 AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF CLARKSVILLE, IOWA BY AMENDING CHAPTER 155, RESTRICTED RESIDENCY DISTRICT. RCV/ Ayes: Saulsbury, Doty, Sherburne, Kielman, and Reints. Nays: None. Absent: None.

Water Rate Discussion. Kielman suggested a 3% rate increase and then a 1 % increase for the next 3 years. Council will discuss a possible effective date and increases.

Motion Sherburne, Doty to table setting water rates at this time.

Mayor stated that the more than two accessory buildings was our mistake when added to letter, but they had moved a building without obtaining a building permit and the landlord would need to submit the permit. The landlord had told deputy clerk that he did not want the shed on his property and wanted it removed.
